

#### INVESTMENT OBJECTIVE

The actively managed fund primarily invests in inflation-indexed bonds of all maturities from domestic and foreign issuers of high credit rating. To actively manage inflation risk exposure nominal bonds and futures may be added. Foreign currencies are predominantly Euro-hedged. The investment in inflation-linked bonds enables the investor to benefit from globally rising inflation rates. Losses of purchasing power - measured against the price indices - can thus be offset in the medium to long term.




