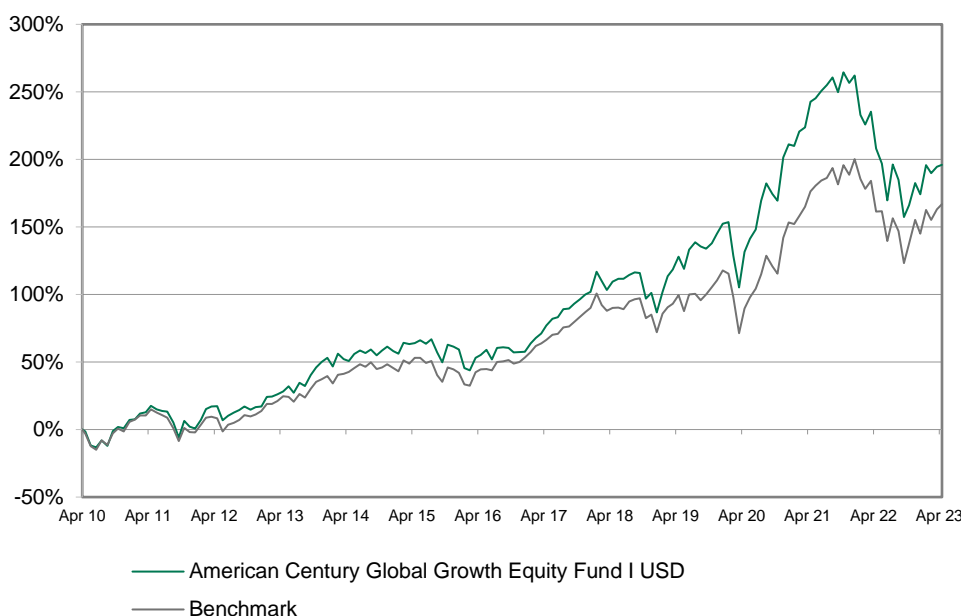

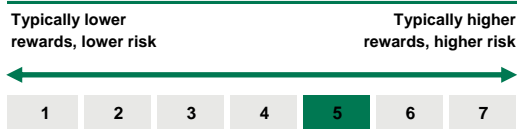

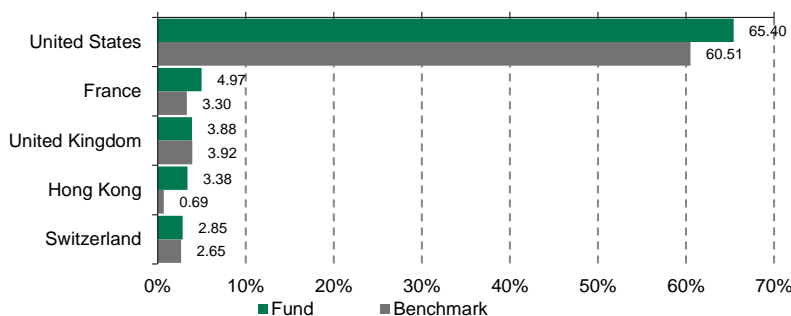

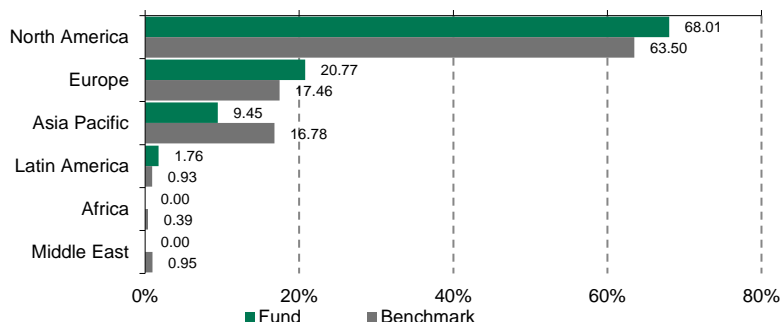

**GEOGRAPHIC BREAKDOWN**

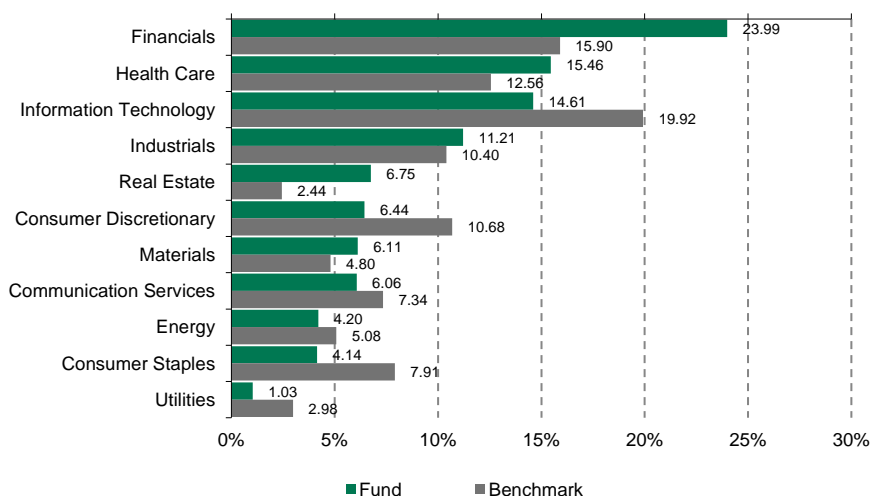
**Top 5 Active Country Weights**
