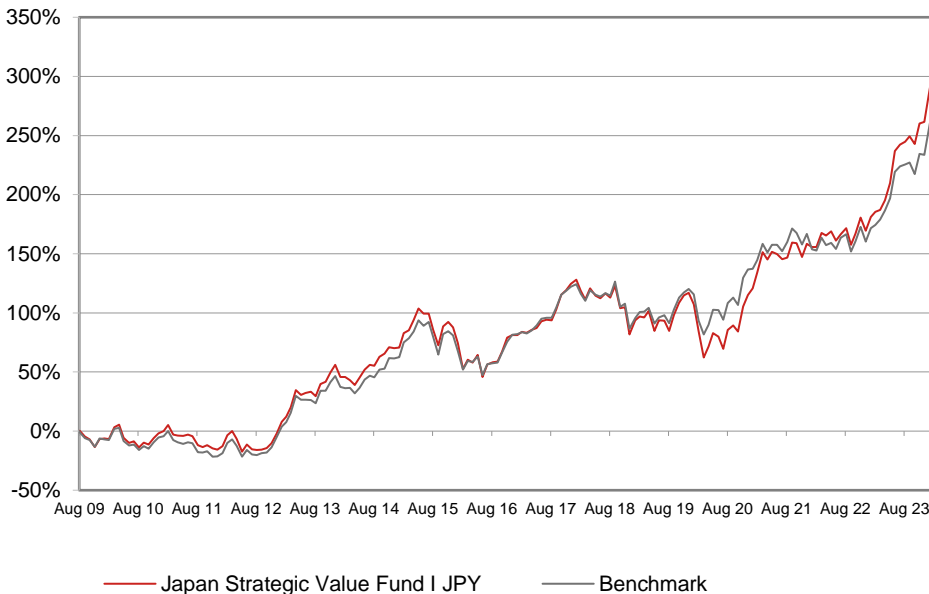


INVESTMENT OBJECTIVE

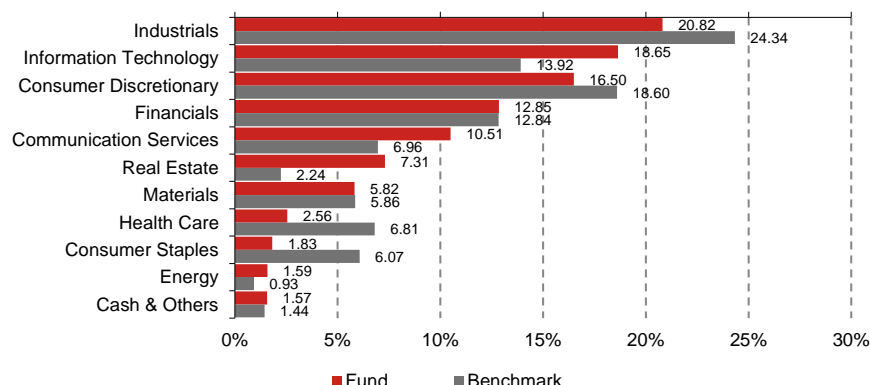
